

Privacy Policy of ABRAMIS Sp. z o.o.

1. Data Controller of customers' personal information is Abramis Sp. z o.o. with headquarters in Łomianki (05-092), at ul. Łąkowa 52a, entered into the register of entrepreneurs kept by the District Court for the capital city of Warszawa – 14th Commercial Division of the National Court Register (KRS) under KRS no. 0000194763, NIP 1180014612 (hereinafter referred to as: Abramis Sp. z o.o.);
2. The processing of personal data is performed in accordance with the rules laid down in the Personal Data Protection Act, Regulation 2016/679/EU of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation of 27 April 2016), the Act on Providing Services by Electronic Means and the provisions of the present Privacy Policy and the implemented and applicable at Abramis Sp. z o.o. Information Security Policy.
3. The provision of Customer's personal data is voluntary and its processed:
 - 1) in order to comply with the provisions of law;
 - 2) in order to implement an agreement;
 - 3) for promotion, commercial and other activities of Abramis Sp. z o.o., with consent of data owner;
 - 4) in order to implement activities for the Customer;
4. Legal basis for personal data processing, in the case referred to in section 3, item 1, is a legal authorisation to process the data necessary for the purposes of a lawful action, and in the case referred to in section 3, item 2, it is a contractual authorisation to process personal data where necessary for the fulfilment of justified purposes pursued by the Data Controller.
5. For performance of Service Provider's activities referred to in section 3, item 3 and 4 the Customer shall voluntarily give informed consent to the personal data processing by ABRAMIS Sp. z o.o., separately for each of the data processing purposes.

6. Personal data collected by the Service Provider may be made available to relevant authorized state authorities, upon their request, on the basis of relevant provisions of law. It may also be made available to other persons and entities – in the cases provided for by the provisions of law, only with prior consent of the data subject.
7. Processing of personal data of Customers and the personal data provided by them may concern the following:
 - Names and surnames,
 - E-mail address,
 - Shipping address,
 - Telephone number,
 - NIP [Tax ID number],
 - PESEL [Personal ID number],
 - Other data necessary for the specific purpose of the processing.
8. The processing of personal data as provided for in section 7 shall always be carried out in accordance with the principles of data minimisation and adequacy for the relevant purpose.
9. Abramis Sp. z o.o. provides appropriate technical and organizational measures to ensure the security of personal data provided by the Customers, in particular, by preventing access or processing of such data by third parties, in breach of the law, to prevent loss, damage or destruction of data.
10. Customers have the following rights:
 - to access the content of own personal data,
 - to supplement, correct and update the content of personal data,
 - to transmit personal data,
 - to limit personal data processing,
 - to request temporary or permanent suspension of personal data processing,
 - to remove personal data,
 - to revoke consent for personal data processing,

- to object to the processing of personal data,
- to lodge a complaint with a supervisory authority.

11. The personal data will be processed in accordance with the principles set out in the General Data Protection Regulation of 27 April 2016, other applicable regulations, Privacy Policy, Information Security - Personal Data Protection Policy.
