

Information clause for the processing of personal data by Abramis Sp. z o. o.

In connection with the implementation of the requirements of Art. 13 Regulations of the European Parliament and Council (EU) 2016/679 of 27 April 2016 on the protection of persons in connection with the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC - General Data Protection Regulation (hereinafter: "GDPR"), we would like to inform you about the principles of personal data processing and your rights in connection with data processing personal data in Abramis Sp. z o. o. The following rules apply from May 25, 2018.

1. The administrator of your personal data is Abramis Sp. z o. o.: ul. Łąkowa 52a, 05-092 Łomianki, NIP number: 1180014612, KRS number: 0000194763; represented by the Company's Management Board (hereinafter: Administrator).
2. The Administrator has appointed a Data Protection Inspector - Mr. Dariusz Piesio, who can be contacted via e-mail by sending an e-mail to the following address: dariuszpiesio@gmail.com or by sending correspondence to the Administrator's address.
3. The Administrator processes your personal data in accordance with applicable law and the internal Information Security Policy,
4. Your personal data will be processed for one or more specific purposes arising from the provisions of the GDPR if:
 - a. the processing of personal data will be necessary to perform a contract to which the data subject is a party, or to take action at the request of the data subject before concluding the contract (Article 6(1)(b) of the GDPR),
 - b. the processing of personal data will be necessary to fulfill a legal obligation (Article 6(1)(b) of the GDPR),
 - c. the processing of personal data will be necessary to implement the legitimate interest of the Administrator related to the offered products, services provided and concluded contracts (Article 6(1)(f) of the GDPR).
 - d. we receive your consent to the processing of personal data (Article 6(1)(a) of the GDPR).
5. In connection with the processing of data for the purposes referred to in point. 4, the recipients of your personal data may be authorized bodies and entities, including persons and entities carrying out tasks and providing services to the Administrator.
6. Your personal data will be stored for the period necessary to achieve the purposes specified in point. 4, and thereafter to the extent and for the period necessary to protect the Administrator's interests or the period required by the provisions of generally applicable law.
7. In connection with the processing of personal data by the Administrator, depending on the purpose of their processing, you have certain rights under the conditions and principles specified in the provisions of the GDPR
8. You have the right to lodge a complaint with the President of the Personal Data Protection Office (PUODO) ul. Stawki 2, 00-193 Warszawa, in a situation where the processing of your personal data by the Administrator would violate the provisions of law regarding the processing of personal data.
9. In the case of data processing based on consent - Art. 6 section 1 letter a GDPR, its withdrawal may take place at any time, which does not affect the lawfulness of the processing of personal data that

was carried out before its withdrawal. Please send requests to withdraw consent to the Administrator's address.

10. In the case of data processing for the purposes specified in Art. 6 section 1 letter b GDPR, providing personal data is voluntary, but necessary to achieve these purposes.

11. Providing data is obligatory when the premise for the processing of personal data is the provision - Art. 6 section 1 letter c GDPR.

12. Your data may be processed in a traditional and automated manner, but will not be subject to profiling.

13. Information regarding the processing of personal data will be published on the Administrator's website.
